2. Saturday, October 15th from 9am – 10:30am. Early entry to the show starts at 10:30am

What we will be providing:

1. Promotional threads on Reef Central, Facebook and other Social networks prior to the event.
2. Directional Signage outside the event.
3. Electricity for each row
4. Saltwater: Natural seawater
5. 8-foot table and 2 chairs if requested

What you need to bring:

1. Electric cords and power strips for your booth
2. Banner or signage for your booth
3. All of the equipment that you will need to show, sell and package your sale items.
4. Containers for carrying water from the water bin to your display tanks.
5. Change!! We will not have cash available for you.
